This leaflet contains information regarding Child Protection and Safeguarding procedures at Five Acre Wood.



## Staff Training.....

Every member of staff receives annual safeguarding and child protection training. This usually forms part of the staff development days in September and covers a range of national and local safeguarding issues. This year training included, but was not limited to:

- FGM
- Radicalisation, including PREVENT
- Online Safety
- CSE/CCE
- Child on Child abuse
- Domestic Abuse and Operation Encompass
- Gangs and County Lines
- Honour Based Violence
- Sexual violence and Harassment
- Definitions of Abuse
- Support agencies such as Early Help and Social Services
- Attendance
- Low level concerns
- Whistleblowing

In addition there is a Safeguarding briefing to all staff once a week which also covers many aspects of child protection. Some of the themes covered include;

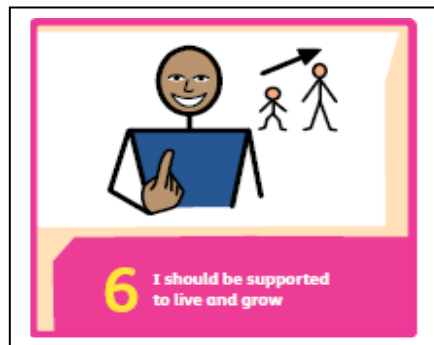
- What to do if a child makes a disclosure
- Record keeping

A weekly Safeguarding Bulletin complements the briefing.
